



History of Holistic Admission



Holistic admission is not a new idea

- 1966 Thresher's College Admissions and the Public Interest
- Uncovering student talents beyond test scores and grades
- Non-academic factors should be considered in the context of the student's environment
- Through the 70s and 80s, selective colleges created a "personal rating" to accompany the academic rating
- Extracurricular activities; civic engagement
- Teacher recs
- Essays discussing unique experiences or mitigating circumstances



History of Holistic Admission



- 2000s: Education Conservancy- "College Unranked"
- Movement away from rankings' obsession with tests
- 2016 and 2019: Making Caring Common (Harvard)
 200 admissions deans agreed that colleges--
- Should assess students' ethical engagement and contributions to others (in context)
- Should redefine achievement in ways that level the playing field and reduces excessive achievement pressure
- Character Collaborative (2016-present) advocates for the consideration of character in admissions decisions
- Creates training courses to help guide admissions leaders in this space





With the explosion of "test-optional" during COVID: a new era for Holistic Admission has emerged
